## FURTHER INSTRUCTIONS AND REQUIREMENTS

1. To qualify as a Nominee a person must be of good character and to have made a significant contribution toward the preservation, promotion and/or performing of COUNTRY MUSIC **WITHIN THE STATE OF MAINE.** Please expound on the background.
2. Each nomination **MUST** be submitted on the official "*Hall of Fame Nomination Form*" - please only ONE NOMINEE/DUO PER FORM. A DUO may constitute one nominee.  
Additional information **MUST** be supplied on 8 ½ X 11 white paper, typed or printed clearly, and attached to the Nomination Form. Include one recent 5X7 black & white or color professional appearing photograph.
3. On a separate sheet please submit a detailed biography of nominees background to include first musical or entertainment interests, influences, earliest known dates and locations of performances, such as: stage, dances, TV, radio, recordings, etc. Also include newspaper clippings, photographs, and any documentation pertaining to the nominees musical background. Tell if nominee is still active in the Country Music field and what their status is. If deceased please give name and address of spouse and/or known relative or close contact person.
4. A nominee need not be a member of any active Country/Bluegrass Association within the state of Maine. A person may submit no more than two nominations per year and be willing to vouch for the nominee's character.
5. Each Nomination Form **MUST** be signed by the person who is nominating along with their mailing address and telephone number. This is necessary in the event that the Induction Committee needs more information.
6. Make copies of valuable historical material before submitting as all materials are non returnable and become a permanent file to be used for future reference.

**FAILURE TO THOROUGHLY ANSWER ALL QUESTIONS AND PROVIDE DOCUMENTATION MAY DISQUALIFY THE NOMINATION.**
