#### THE THOMAS POINT BEACH BLUEGRASS FESTIVAL RECOGNIZED FOR IBMA INDUSTRY AWARD



On August 4th, The International Bluegrass Music Association announced the nominees for this year's IBMA Industry Awards and IBMA Momentum Awards. The Thomas Point Beach Bluegrass Festival in Brunswick, Maine was among the nominees for Event/Venue of the year. The announcement was made on SiriusXM Bluegrass Junction.

The IBMA Industry Awards will take place Thursday, September 29, during IBMA World of Bluegrass (September 27-October 1 in Raleigh, NC).

The Industry Awards recognize outstanding work in categories including Broadcaster of the Year, Event of the Year, Graphic Designer of the Year, Liner Notes of the Year, Writer of the Year, Sound Engineer of the Year, and Songwriter of the Year. Nominees in each category are selected by specially appointed committees made up of bluegrass music professionals who possess significant knowledge of that field. The recipient of each award is decided on by the Panel of Electors, an anonymous group of veteran bluegrass music professionals selected by the IBMA Board of Directors.

The Event/Venue Award recognizes events (festivals, concerts, event series, virtual events, or other live performance productions) for their outstanding accomplishment and service to bluegrass music in the field of event production. The event must have taken place and its accomplishments evident within the eligibility period. The event will be judged by its ability to further bluegrass music in its region or area of service; production quality in terms of presentation and organization; environment; and overall audience experience.

#### THE THOMAS POINT BEACH BLUEGRASS FESTIVAL RECOGNIZED

The Thomas Point Beach Bluegrass Festival was founded by Pati Crooker Mulligan in 1979. Pati's son Michael Mulligan and his wife Jen are now owners of the park and campground. They have been producing the event since 2017 in coordination with event planner, Shari Elder. #### WINTER BLUEGRASS JAM NEWS

The pandemic is winding down, it seems – thank heavens! – and we're excited to find that some wintertime bluegrass jams will be starting up soon. Here's where we are right now with that.

#### EASTERN (BREWER) JAMS

The BMAM-sponsored Eastern Jam will be held in Brewer, at the Brewer Grange, on the first Sundays of the month, starting Oct. 2, thanks to some new volunteers. Dale Canning headed this jam up for several years, doing a wonderful job, but Dale is moving south this year. We're awfully glad some new folks, including Larry Corbet, have stepped up! This jam will run from 2:00 to 5:00.

The Brewer Grange will hold their own (non-BMAM) jam on 3rd Sundays of the month – same time, same place. First jam will be on Oct. 16, 2:00 to 5:00 PM.

The Brewer Grange has two floors, so there's room for two levels of pickers; pickers are, of course, welcome to try both levels and find out what works best for them. Refreshments are offered for sale by the grange.

#### SOUTHERN JAM (PORTLAND AREA)

The BMAM-sponsored Southern Jam is expected to resume Sunday, October 16, at 1:00 PM. The location will be Wescustogo Hall, located on Rt 9 in North Yarmouth. The street address is 120 Memorial Highway.

While there are still details to be finalized, we expect to have a total of 6 Jams, once each month, from October 2022 to March 2023, at the same location. We will post further information as it becomes available on our Website and FaceBook page.

#### **NEW FARMINGTON JAM**

A new independent jam is starting up in Farmington. It will be held on 4th Sundays of the month, from 1:00 to 4:00 PM. First jam will be on Oct. 23. Admission is free at this point – this could change in the future.

The venue is the Farmington Community Center, 127 Middle St., just a couple blocks from downtown Farmington – lower level, accessible from the parking lot.

There's plenty of room for at least 3 separate jams in this building, so we're hoping for a big turnout of pickers and singers of all levels.

# MAINE WRITERS KEACH & TRIPPE WIN 2022 PODUNK BLUEGRASS SONGWRITING CONTEST



I'm proud and happy to report that "Can't You Hear It Calling," a song written by Yarmouth bluegrass musician and writer Jeff Trippe and I, took first place at the Podunk Bluegrass Songwriting Contest on August 12. An article in Bluegrass Today described the song in this way: "... a song about Bill Monroe's 1923 Loar-signed Gibson F-5 mandolin. The lyrics imagine that the instrument is lonely sitting behind the glass at the Country Music Hall of Fame & Museum in Nashville, and calls out at night, hoping to make music once again."

Jeff and I went to Goshen, Connecticut to perform the song in the contest, and we were thrilled to be joined onstage by three other musicians: my wife, Liz, on bass (a rare performance since her musical retirement); and two top professionals – Bill Thibodeau of Rock Hearts, and Max Silverstein of Seth Mulder & Midnight Run – both former musical colleagues of Liz and me. Bill and Max played super-great, really enhancing the experience for Liz, Jeff and me.

At next summer's Podunk Festival, we'll get another thrill as finalists in the band competition will all be required to render a version of "Can't You Hear It Calling." When I won the Podunk Songwriting Contest in 2017 with "Bear in the Barn," I got to hear some great renditions of that song in the next year's contest.

Jeff and I have been writing songs together for about three years, and we've cranked out a couple dozen songs. A couple of our other songs have been finalists in songwriting contests in Maine and Florida.

#### ALBUM REVIEW

#### IN DREAMS I GO BACK — SETH MULDER & MIDNIGHT RUN

When I went to the Podunk Bluegrass Festival this July, I was really looking forward to hearing Seth Mulder & Midnight Run, since a Maine fiddler, Max Silverstein, who, incidentally, played many shows with me and all the other Sandy River Ramblers before he left Maine to study bluegrass and old-time music at East Tennessee University, is now a member of Midnight Run. I had watched a few of their videos on Youtube, so I knew they were really good . . . but I was really surprised at just how good they were in person! This

is a good, traditional, driving band! One of the best young bands out there.

Thus, it is with great pleasure that I review their latest album, *In Dreams I Go Back* — an album that I love from beginning to end.

Seth Mulder, who hails from North Dakota (of all bluegrass places), is a very strong, straight-ahead bluegrass vocalist. At times, his singing evokes Del McCoury or Dudley Connell a little bit; at other times, maybe Jesse McReynolds; but he never seems to be aping or copying other vocalists. Like almost any bluegrass singer, he's learned his craft by studying those who have gone before, but now he sings like Seth Mulder, and the elements of his singing reflects his heroes and models. (Dudley Connell wrote the album notes, by the way; they seem to be good friends with mutual admiration.)

The other main lead singer in the band is guitarist Ben Watlington, and he's really good, too. Ben really shines on "Carolina Line," and the album's title song.

The trio's harmony is outstanding as well, with banjoist Colton Powers on tenor, and bassist Max Etling on baritone much of the time. These guys really do it right, with just enough fancy embellishments, calls-and-responses, and other adornments to keep it very interesting, yet still solidly traditional. Usually, Powers and Etling handle the harmony parts whether Mulder or Watlington is singing lead. The trio singing has a lot of Osborne Brothers influence to it, but it's even more country/traditional sounding than that.



The gospel number "My God Will Set Me Free" is a calland-response quartet number, and it's excellently rendered.

As for the picking, it, too, is terrific throughout. Powers is consistently crisp, clean, innovative and driving on the banjo. His Scruggs-style guitar finger picking is great on the gospel number, too. Mulder's mandolin is nuanced — it's solidly bluegrass all the way, but there are creative surprises all over the place.

As for Silverstein, his fiddling is powerful, with wonderful tone and great ideas. Max

was an outstanding teenaged fiddler while he was in Maine, but he's obviously been hitting it hard for the past five years. And I think he's even better now than he was when they recorded the album. Watlington's occasional guitar leads are really good, thought not excessively showy, and his rhythm playing is powerful as well.

The song selection is great, too; I like every song on the album. There are several songs in the "I miss my old home in the mountains" genre; a ballad, "In Dreams I Go Back," on the same topic that evokes the Stanleys' "The Fields Have Turned Brown"; and a song about a soldier hoping to go home to his love, "Ruby Ann", even as the bullets fly around his head. The band does a great job on the old George Jones song, "A Picture of Me Without You".

One slight surprise is "Your Love", which is kind of a rock song in mood and beat. It reminds me slightly of the Stanleys "Finger Popping Time", with this difference: the Stanleys seemed slightly out of their element, while being good sports about it; Midnight Run seems completely at home with this number and it's one of my favorites on the album.

This album is just terrific from start to finish, and these guys have a wonderful stage show, as well. They tour hard and fast, so I'm pretty sure we'll all have plenty of opportunities to see them in New England over the next few years. I'm looking forward to it, and anxious to hear their next album; in the meantime, I'll probably wear this one out.



#### ROLAND WHITE BIOGRAPHY BOOK REVIEW

MANDOLIN MAN by Bob Black (University of Illinois Press, 2022)

– Stan Keach

The last issue of the Bluegrass Express (June, 2022) included an article about mandolinist Roland White, who died on April 1, 2022, noting that White was a Maine native, born in Madawaska, Maine, and raised in Madawaska and Lewiston until he was 16 years old.


A few weeks after writing that article, by coincidence, I came across a new biography of Roland White, *Mandolin Man*, written by Bob Black, a banjo player from Iowa who, like White, had been a member of Bill Monroe's Blue Grass Boys (at a different time than when White played with Monroe).

Black's biography of White was published in 2022, just a month or two before White's death, and so it covers almost all of Roland's life. I was familiar with Roland White's music; I knew him to be a great picker, a compelling singer, and an educator who produced many influential books and video lessons; but until I read the book, I often thought of Roland primarily as Clarence White's brother. Clarence, of course, was an enormously important flat picker, whose jazzy, innovative playing was a strong influence on Tony Rice and virtually every bluegrass lead guitar player that followed him; Clarence also played in the great rock group, the Byrds, and helped invent the B string bender, that allowed Telecaster players to imitate a pedal steel guitar. Black's biography helped me gain a deeper understanding of Roland's importance. Roland, after all, was six years older than Clarence, and was perhaps most responsible for the early direction and focus of the Kentucky Colonels, the innovative band that the brothers earned their earliest fame in. Over the years, Roland appeared on over 60 albums, and was elected to the IBMA Bluegrass Hall of Fame in 2017.

I won't repeat all the biographical information I included in the June, 2022 memorial article, but, to remind readers of the scope of Roland White's contributions, it's worth noting the bands that he played in during his 70-odd years in bluegrass music: The Kentucky Colonels; Bill Monroe & the Blue Grass Boys; Lester Flats & the Nashville Grass; Country Gazette; The Nashville Bluegrass Band; The New Kentucky Colonels; and The Roland White Band — an impressive list by any standard!

I recommend this book highly; it's chock full of historical detail, interesting anecdotes, and insightful analysis. I must admit that there are occasional examples of unsubstantiated hyperbole (example: the assertion that the Nashville Bluegrass Band "[raised] bluegrass to its highest level ever" (page151). This kind of statement sounds like advertising or political propaganda and should be left out of serious biographies, unless qualified by a phrase like "in my opinion." Still, the positive aspects of this excellent biography outweigh the negatives by a good margin.

*Mandolin Man* is available from the University of Illinois Press, and it's on the shelves in the Maine State Library (and thus, available at your local Maine library through the inter-library loan program).

We estimate that probably 60-70 people or more came; we went through several smaller pots of de-caf coffee, and the large tank of regular coffee was greatly depleted. We do not know how many members were actually in attendance.

The event had been announced by TPB MC's the previous afternoon, but the announcements left out the "Members Only" caveat, and so the demand was hard to gauge. We had previously estimated 35-40 members, plus some additional & guests/spouses, would attend.

The planning for the event itself had called for all food items to be purchased from Brunswick Dunkin' Donuts. But due to the confusing announcements the previous day, it was decided to go with on-site vendor Foggcutter Coffee for the coffee itself.

The cost of the coffee, plus some additional food items, was included as an "In-Kind Donation" by a member.

We were prepared to offer new memberships at the event site, and in addition we sold 1 BMAM coffee mug, out of several displayed. A total of six memberships and one mug transaction were booked, for \$105; these transactions were recorded in the September 2nd BMAM festival booth paperwork.

The BMAM hosts for the event were Laura Richardson, Dave Robison, and Bob Bergesch.
